

- 5. The purpose or purposes for which the corporation is organized are:
- (a) To engage exclusively as an organization to advance educational, scientific and charitable endeavors within the meaning of 501 (c) (3) of Internal Revenue Code of 1954 or a similar aection as amended and in pursuance of these purposes said Corporation shall conduct its affairs as follows: To advance education at the elementary, secondary, college and post graduate levels by conducting research programs in management of schools at all levels; To better enable the members and the general public to conduct the management of schools of all levels in the planning, organizing, co-ordinating and improvement thereof for the benefit of the public attendance and the community; To provide for the membership of the Association of School Business Officials of the United States and Canada and the public the findings of such research and to make same available thereto and to conduct field research experiments in the aforesaid areasfor the benefit of those attending schools and the public in general.
- (b) The foregoing purposes and the objectives of Paragraph (a) shall be the exclusive purposes and objects of this Corporation and be directed toward the advancement of education, public safety, science and charitable purposes to lessen and alleviate the financial burdens and obligations of local, state and national government in the area of education, and educational research and public school safety research.

(c) This corporation is not organized for the pecuniary profit of its directors, officers of members; nor may it issue stock nor declare nor distribute dividends, and no part of its net income inure to the benefit of any director, officer or member; and any balance of money or assets remaining after the full payment of corporate obligations of all and any kinds shall be devoted solely to the charitable, educational and benevolent purposes of the corporation, and further this corporation is not organized to carry on the publication of propaganda or to otherwise attempt to influence legislation nor to participate or intervene in any political campaign for any candidate or candidates for public office.

The foregoing purposes shall be construed as both objects and powers.

6. Powers

The corporation has such power as may be needed to carry out the foregoing purposes as set forth in Article 5, hereof and such power shall not be limited except as provided therein.

7. Dissolution and Liquidation.

In the event of the dissolution and liquidation of the corporation and prior to the completion thereof, all of the assets, property, income and all other funds of the corporation not owned or held upon a condition requiring return, transfer or conveyance by reason of dissolution shall be expended for or applied to the purposes of the corporation, or one or more of such purposes by transferring and conveying such assets, property, income and funds to one or more corporations or organizations, organized and operated exclusively for charitable,

scientific, literary or educational purposes, to which exemption from income taxes has been granted under Section 501 (c) (3) of the Internal Revenue Code of 1954 or comparable provisions of the prior or subsequent Federal Income Tax Laws, and no part of such remaining assets, property, income or funds, shall be distributed to members or to any other persons whatsoever.


