## In your opinion, what is the most important issue school business officials will face during the next five years, and how should ASBO International begin to address that issue now?

I believe that the most important issue school business officials will face during the next five years is related to the staffing crisis in many industries have more openings than qualified, available staff. I recently read an article that stated that 200,000 accountants left the accounting profession in 2022. Just on the financial side, we will have to compete at a level for financial staff that we have not experienced in the past. How will we encourage the next generation to want to enter and stay in this space? Similar shifts are happening in other school business professions.

ASBO International should begin focusing on encouraging membership at many levels within school organizations to help develop, grow and retain our future leaders. A great step is the district professional learning memberships that will give access to professional development that traditionally has been limited to those who can travel for conferences. I believe this should include expanded trainings for entry level positions.
